EDITORIAL NOTICES

The object of *Gut* is to publish original papers and reviews concerned with practice and research in the field of gastroenterology. The field is that of alimentary, hepatic, or pancreatic disease, and papers may cover the medical, surgical, radiological, or historical aspects. They may also deal with the basic sciences concerned with the alimentary tract, including experimental work. The report of a single case will be accepted only if it is of sufficient interest in relation to a wider field of research.

There will be a section devoted to short papers on laboratory and surgical techniques and methods of investigation where these are not part of a larger survey.

Papers should be addressed to the Editorial Secretary, *Gut*, Central Middlesex Hospital, Park Royal, London, N.W.10. Papers are accepted on the clear understanding that the subject matter has not been and will not be published in a separate journal.

Manuscripts should be typewritten in double spacing on one side of the paper only and carefully revised, as alterations in print are costly and, apart from verbal corrections, will be charged to the contributor.

Photographs and photomicrographs should be printed on glossy paper; they should be submitted unmounted, and lettering, when required, should be indicated on tracing paper fixed over the print. Drawings and diagrams should be made boldly in black ink, and any lettering lightly inserted in pencil. Photographs of diagrams are rarely satisfactory for reproduction. Legends should be typed on a separate sheet of paper.

References to papers in the text should be made by inserting the name of author followed by year of publication in brackets. At the end of the paper, references should be arranged in alphabetical order of author's name. Such references should give author's name, followed by initials and year of publication in brackets, the name of the journal in which the article appeared, the title of the article quoted, the volume number in arabic numerals, followed by number of first page of article. Abbreviations are according to *World Medical Periodicals* (published by B.M.A. for World Medical Association), thus:

Brown, A. B. (1956). *J. roy. Coll. Surg. Edinb.*, 169, 427.
