ANTIBIOTICS AND THE INTESTINAL FLORA

Treatment with broad spectrum antibiotics suppresses the normal flora, which may be replaced by abnormal resistant organisms causing diarrhoea.

This change can be prevented or reversed by the implantation of *Lactobacillus acidophilus* which has been rendered antibiotic-resistant, and is thus able to multiply freely under these abnormal conditions. The products of growth of this organism are inimical to that of many other bacteria^{1,2} and thus contribute to its rapid preponderance over other species.

Oral treatment with antibiotic-resistant *L. acidophilus* in the form of ENPAC has been shown to eliminate *Candida* from the faeces of infants with antibiotic-induced diarrhoea, with relief of symptoms succeeded by rapid gain in weight^{3,4} and greatly to reduce the numbers of staphylococci in the faeces of patients treated with tetracyclines.⁵

ULCERATIVE COLITIS

Ulcerative Colitis is a group of non-specific inflammations of the large bowel which includes ischaemic colitis and Crohn's diseases. The definition and pathological characteristics of the disease must therefore be defined in each patient before satisfactory treatment can be attempted.

This new book provides a comprehensive summary of contemporary knowledge. Professor Goligher and his colleagues at the colitis clinic at Leeds Infirmary have made a special study of the condition, and their data, collected over the past twelve years, has been fully analysed and assessed. The results of these studies have now been carefully edited and form the substance of this present monograph. The authors are fully aware of the gaps that exist in present-day understanding of ulcerative colitis, particularly in relation to the aetiology of the disease and its medical management, but their book reflects the substantial increases in knowledge of the course and outcome of the condition under conventional medical treatment, the refinements to surgical techniques, post-operative care, and complications that may occur especially in ileostomy management. An authoritative statement on the pathology of ulcerative colitis has been contributed by Dr Basil Morson.

The presentation of the data in this monograph has been carefully considered to make it convenient for study and reference and it will be an essential addition to the library of all surgeons and physicians who are required to deal with this puzzling and incapacitating condition.
