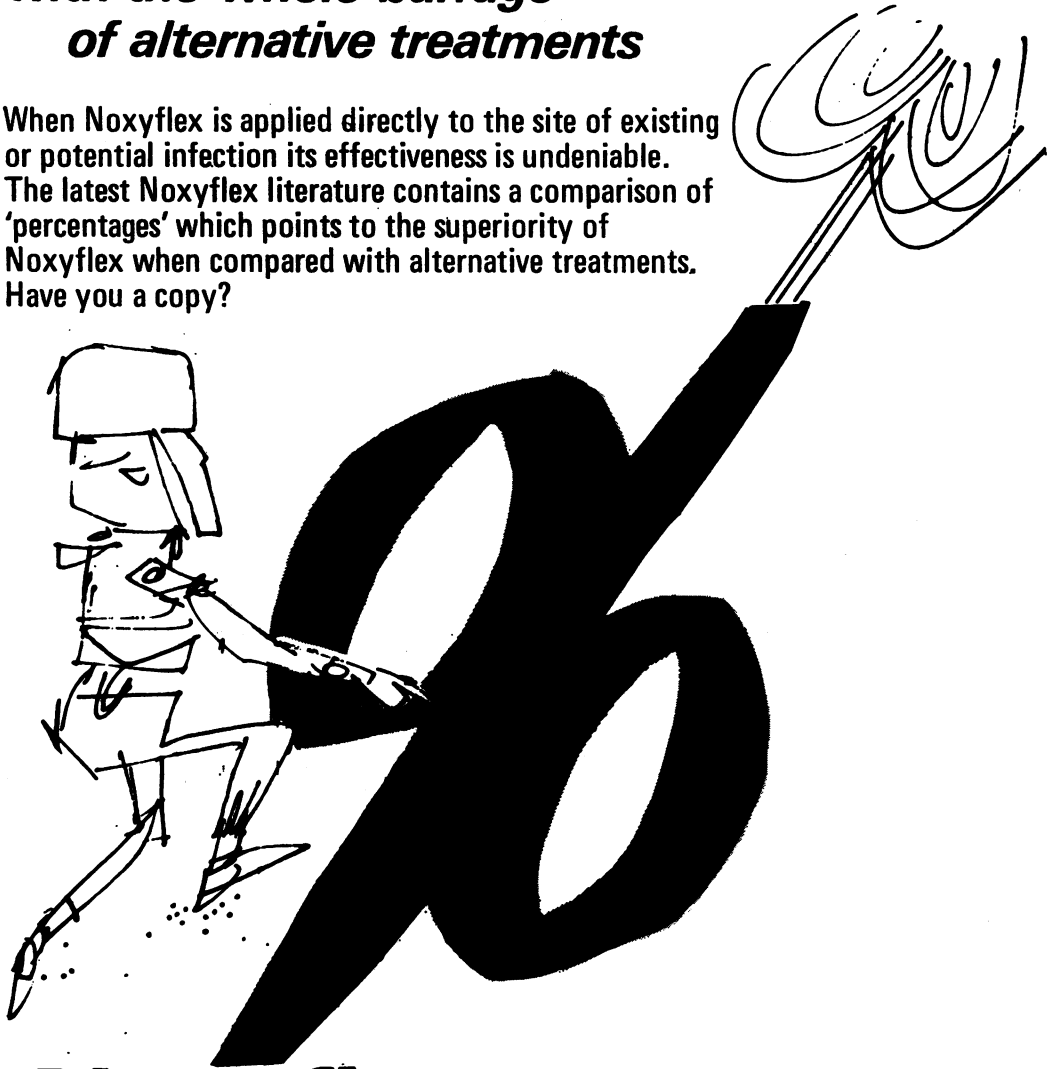

Obesity is not only adverse to beauty, it is a disease and only too often a severe blow to the person concerned. It is therefore of supreme importance to carry out researches in the field of adiposity. In his book, Prof. Dr. Ries endeavours to elucidate the entire problem on the basis of his own ideas and results and of international literature. The problem is dealt with from the viewpoints of chemistry, physics physiology, psychology, anthropology and sociology, since all this was crucial for the selection and carrying-through of the investigations. At the same time the author tried to examine and review the international literature on obesity so that young scientists interested in the subject can more easily make themselves acquainted with the problem.
